Reuse and Cleaning Instructions for 10A Reusable Masks (non-medical use)

10A 可重複使用口罩系列(非醫用)的重複使用及清潔說明

1. The method and instructions here apply only to the 10A Reusable Masks (non-medical use)

2. Please use your own commercially available ≥75% ethanol spray for cleaning the masks as it is not included in the mask package.

敬請您自備>75%乙醇水性溶液噴霧以作清潔口罩使用,口罩套裝未提供噴霧。

3. Please clean the mask before reuse. It is recommended that the 10A Reusable Masks be cleaned after 6-8 hours of use. If the mask is damaged, or exposed to hazardous/harmful pollutants, please dispose of it appropriately.

請在重複使用口罩前做好清潔。建議在使用 10A 可重複使用口罩系列時,每隔 6-8 小時清潔。若口罩已受損、已嚴重污染或接觸過有毒有害汙物時,請妥善棄置口罩。

4. To clean the reusable mask, please spray the outer surface (front) of the mask with ≥75% ethanol spray:

a. Spray onto the outer surface (front) of the mask from 4 inches 3 times. Ensure the spray covers the whole outer surface (front) of the mask.

b. Avoid touching the outer layer (front) of the mask during the cleaning process.

d. Only wear and reuse the mask when it is completely dry.

5. The NANOGO™ filter element material used in the 10A Reusable Mask has been tested and the results show that it can be cleaned and reused up to 10 times, without any significant reduction in filtration efficiency while still maintaining its original protectability and functionality.
